

TERMS AND CONDITIONS OF 'FREE WEDDING'

Introduction

1. Just About Group Limited, a company incorporated in England & Wales, with registered number 12611779, and whose registered office is at International House, Constance Street, London, E16 2DQ, is the 'PROMOTER' of this competition and can be contacted either via email – hello@justaboutgroup.co.uk – or telephone – **08007563454**.

Eligibility

2. The following lists the specific eligibility requirements for the competition:

- 2.1. Entrants must be over the age of 18 years at the time of entry to the competition.
- 2.2. Entrants must be residents of the UK.
- 2.3. Entrants cannot be a member of the PROMOTER'S business, nor a relative of an employee of the PROMOTER.

3. There is no cost to enter this Competition

Dates

- 4. The Competition opens on Sunday 14th February 2021.
- 5. The Competition closes on Saturday 17th April 2021.
- 6. The draw for the winner will take place on Sunday 18th April 2021.

How To Enter

7. In order to qualify for entry, the entrant must perform ALL of the following:

- 7.1. Entrant must 'follow' the PROMOTER'S Instagram account - @just.about.weddings - OR 'like' the PROMOTER'S Facebook account - @JustAboutWeddings - and be found to be a 'follower' or 'liker' of either of these accounts on the closing date.
- 7.2. Entrant must 'share' the PROMOTER'S 'competition announcement' post on their Instagram 'story' OR their Facebook account.

10. All individual products and services can ONLY be chosen to be supplied by suppliers from the PROMOTER'S Preferred Supplier list. Any product or service chosen outside of this supplier list will be paid for by the winner, and not by the PROMOTER.
